### **COVID 19**

The Government has advised anyone with Covid symptoms, including a persistent cough, high temperature or breathlessness, to self-isolate and remain at home. Father Graham Adamson and the Warden, on behalf of their congregation, understand this can leave some people feeling isolated and are offering help and counselling to anyone affected. Most of us have been in lockdown since March. For some this can create problems, such as when collecting groceries or a prescription or simply having someone to talk to. ## HOLLYBUSH PLAY AREA

The Parish play area at Hollybush Fields has been out of action for some time due to official guidance on prevention of the spread of Covid-19. In the knowledge that play in the open air is good for children, the area was recently reopened. However, we ask users and parents to heed the notices and abide by government advice on hygiene and social distancing. Please also be aware that the roundabout is currently out of commission and in need of maintenance work. The remaining equipment has been checked by an inspector from the Royal Society for the Prevention of Accidents (RosPA) and been declared safe for use.

# WOODLAND MANAGEMENT

There are two areas of woodland managed by the Parish Council. These are Walton Coppice, behind Bluebell Hollow, and Hollybush Coppice. n 2016 we commissioned a report from Staffordshire Wildlife Trust which advised on action necessary to improve the wildlife habitat in each coppice. Some of the recommendations are currently being implemented, but some work will be delayed due to the national emergency and the extra cost involved. Nevertheless, we see this as an important part of improving the Parish environment and safeguarding our assets.

Readers may know that the Parish Council has agreed with Berkswich Primary School for the children to use Hollybush Coppice as a part of their Forest Project. Staffordshire Wildlife Trust has determined the suitability of the Coppice for environmental education and the Council has provided start-up funds. The project is progressing well.

Mindful of the need to preserve our natural environment, the Council is considering planting wildflowers, trees and making other improvements to the grass verges in the Parish. Members of the Parish can help by sensible car parking and providing suitable habitat for wildlife in their gardens.

# **GRASS-CUTTING CONTRACT**

At this time of the year we review the general Parish maintenance contract, which includes grass cutting. This involves assessing the number of cuts per year and the depth of each cut. In a drive to reduce costs we will be checking the exact nature of the annual maintenance and the need for so many cuts. If you have any comments on this issue please let us know through the Clerk's Office.

#### FOOTPATHS

There are several footpaths in the Parish. Some are maintained by the County Council and some by the Parish Council. The question arises whether the Parish should seek to take on the additional responsibility of maintaining more of the public footpaths. This will require agreement with the County Council, and if approved will involve greater expenditure. Unfortunately this will certainly increase the level of the annual precept. However, we understand that tidy footpaths make it easier for people to enjoy the Parish and the beautiful countryside we are lucky to have at our doorstep. Once again, we ask if such a move would receive support.

#### ANNUAL PRECEPT

Your Council Tax contains a contribution towards Parish costs, which is known as a precept. This is the total amount raised through council tax from all dwellings in the Parish area. The charge per property is calculated by dividing the amount forecast by the Parish Council for its needs in the coming year, by the number of properties in the Parish that fall into band D.

#### WEEPING CROSS MEMORIAL

The War Memorial at Weeping Cross is owned and maintained by Berkswich Parish Council. Last November it was noted that those wishing to lay wreaths had difficulty accessing the monument due to slippery surfaces. A general cleanup was indicated and has been scheduled. This must be carried out by a specialist and will incur further cost.
